## Registration/Participation Contract: Binding through May 27<sup>th</sup>, 2023

**\*\*\*IMPORTANT: (Student, if over 18/Parent or Responsible Party for Billing-Please read and initial all statements that you understand and agree)**

### WITHDRAWAL/REFUNDS

- \_\_\_\_\_ a.) If I or my children withdraw for any reason, there will be **NO REFUND** of the registration fee, tuition, or any fees, even if classes have not yet started or the student never attended class. I must give **WRITTEN NOTICE before the 1<sup>st</sup> of the month when I drop classes to avoid tuition charges for that month.** No refunds or deductions are given if a child misses class for any reason, but the child may attend makeup classes.
- \_\_\_\_\_ b.) **NO REFUNDS** will be given due to ANY government, whether state, local or federal, shutdowns for pandemics. If we are ordered to shutdown, classes will be held via Zoom instead of taking place in-person, at our location.

### LATE FEES

- \_\_\_\_\_ c.) All tuition, recital, printer, video, and costume fees are due on the first day of the month according to the payment schedule on the backside of this contract. If I pay any tuition, recital, printer, video, or costume fees **after the 5<sup>th</sup> day of the month in which it is due, regardless of the day of the week the 5<sup>th</sup> falls on, I will be held responsible for paying a \$10.00 or 10% (whichever is greater) late fee to Tari's School of Dance.** My account must have a **ZERO** balance on the 5<sup>th</sup> to avoid a late fee. If your on file credit card/debit card does not clear or is declined, you will be charged a \$10 or 10 percent late fee, whichever is greater.

### ACCOUNTS

- \_\_\_\_\_ d.) **ALL** parents must fill out and submit to Tari's an **AUTOCHARGE AGREEMENT** including credit card or debit card information to charge tuition and ALL additional fees on the first day of each month AUTOMATICALLY, September 1<sup>st</sup> through May 1<sup>st</sup>. **Tuition WILL BE charged in May. THIS IS NOT OPTIONAL.**

### RELEASE AND ASSUMPTION OF RISK

- \_\_\_\_\_ e.) I or my child will **release Tari's School of Dance of liability or responsibility in case of accident or injury** while on Tari's School of Dance property or while attending and traveling to or from any function or **activity involving Tari's School of Dance.**
- \_\_\_\_\_ f.) I agree to assume all risk(s) associated with any potential infectious diseases, viruses, or illnesses, including, but not limited to, COVID-19 (Novel Coronavirus Disease) in connection with any dance lessons occurring in or originating from Tari's School of Dance.
- \_\_\_\_\_ g.) I agree to follow and abide by the following rules while on the premises: using sanitizer before and after entering the dance room, maintaining six feet distance from dance instructors, and wearing a face mask when in the lobby of the studio.
- \_\_\_\_\_ h.) **NO REFUNDS** will be given due to ANY government, whether state local or federal, shutdowns for pandemics. If we are ordered to shutdown, classes will be held via Zoom instead of taking place in-person, at our location.

### DELINQUENT ACCOUNTS

- \_\_\_\_\_ i.) We reserve the right to drop a student from the call rolls if their account is more than **30 days** past due. Past due accounts will be turned over to our attorney or collections.

### DROP OFF & PICKUP

- \_\_\_\_\_ j.) I will drop my child off immediately before his/her scheduled class time and pick up immediately after the scheduled class time, as there is no one to supervise students while they are not in class.
- \_\_\_\_\_ k.) I will allow my child to be screened by a Tari's School of Dance employee with a thermometer prior to entering the studio.

### PERSONAL BELONGINGS

- \_\_\_\_\_ l.) Any personal belongings brought to Tari's School of Dance or any Tari's School of Dance function are the responsibility of the parent and/or student. **Tari's School of Dance is not responsible for any lost or stolen items.** Please come back immediately to retrieve items which are left behind. **We cannot hold any items at the front desk.**

### CLASS PLACEMENT

- \_\_\_\_\_ m.) Placement for returning students is determined by previous teachers. New students are placed by age and those 13 & up are placed in Advanced I to be evaluated for higher placement. This evaluation may possibly result in the student being placed in non-performance classes. Students missing more than 20% of their classes during the year will not advance to the next level. Students in our highest level of recital classes will be moved to non-performance classes after missing **more than 20% of classes at any point during the year** with **NO Refund.**

### RECITAL

- \_\_\_\_\_ n.) Recital will be held on May 26<sup>th</sup> & 27<sup>th</sup> at the LSU Union Theater or Dunham School Theatre. The **recital lasts approximately 3 hours.** No student will leave until the recital is over. I will sign my child in one hour before recital begins and that students are signed out by class when recital is over for safety reasons.
- \_\_\_\_\_ o.) All students **MUST BUY THE CORRECT COLOR OF SHOES AND TIGHTS** for the recital and that colors for shoes and tights will not be announced until January, 2023. These must be ordered by **February 1<sup>st</sup>.** A 10% late fee will be applied after this date.
- \_\_\_\_\_ p.) During the course of the year, parents are responsible for extra fees:  
• **\$45 video fee (January) • \$85 printer fee (February) • \$110 recital fee (March) • Costume fees: \$90-\$540 (varies)**  
These fees are **required** and are due on the 1<sup>st</sup> of the month and are subject to late fees. They are **NON-REFUNDABLE.** (IN THE CASE THAT THE RECITAL IS CANCELLED, recital fees (video, printer, recital) will be CREDITED to your Tari's School of Dance account to use toward future classes. This is NOT a refund. Costume fees are NOT included in this credit.
- \_\_\_\_\_ q.) If I or my child **drops out after the Final Recital Class Drop Date of Thursday, October 27<sup>th</sup> 2022. I will be held responsible for paying all tuition, costume, recital and picture fees, associated with this agreement** and contract to Tari's School of Dance through the 2023 recital, May 26<sup>th</sup> and 27<sup>th</sup>.

### Rejection of this agreement will forfeit ANY future registration at Tari's School of Dance.
